THE ROLE OF THE VETERINARY SECTOR IN COVID-19 PANDEMIC RESPONSES

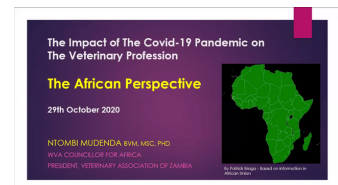
Dr Luis Pedro Carmo – Veterinary Public Health Institute, Vetsuisse, University of Bern

Dr Ntombi Mudenda – President, Zambia Veterinary Association

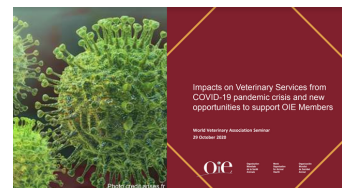

Dr Matthew Stone – Deputy Director-General, World Organisation for Animal Health (OIE)

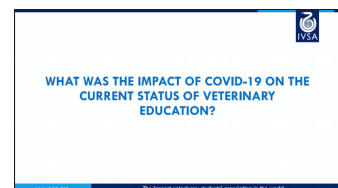
